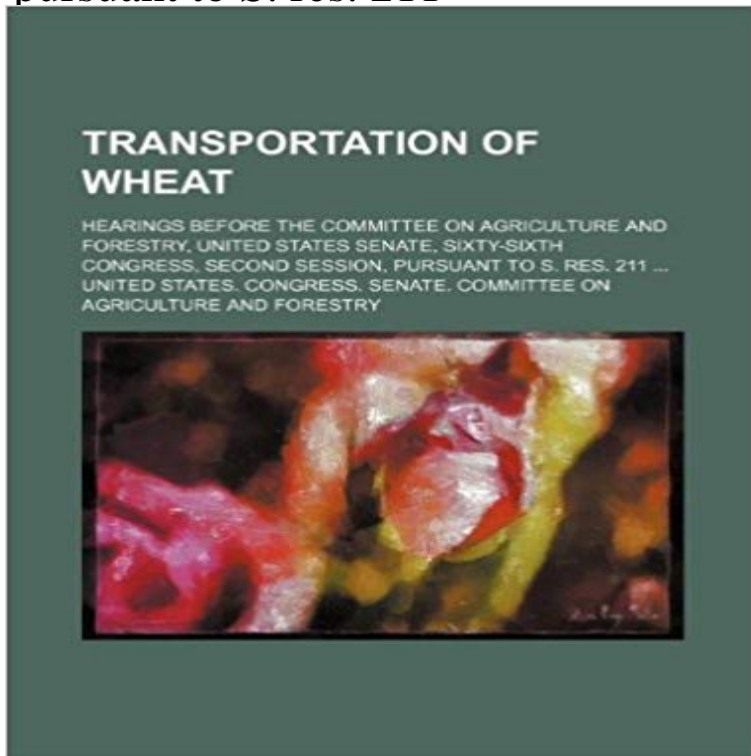

Mr. Barnes. Well, the quality of the crop has largely run to lower grades this year. The Chairman. I know that, but I was anxious to know what grades you bought., Mr. Barnes. I can put it another way, Senator. The Chairman. I wish you would put it in the way I have asked it. Mr. Barnes. All right. I will put it this way: That of the grades of wheat below No. 3, out of all the wheat we have bought we have not bought 2,000,000 bushels of wheat below No. 3. The Chairman. But do you not know how much No. 3 you have bought? Mr. Barnes. No; I do not know. The Chairman. What was the cause of this wheat being No. 3?

Was it because the wheat was shrunken or because it was damp, or that it had a mixture of other grains? Mr. Barnes. That I can not tell you. O...
